## **E-FILING YOUR FORM 2290**

The speed and reliability of electronic filing is now available to you. Filing your Form 2290 electronically through an IRS-approved software provider will save your personal resources (e.g., time & postage) and reduce preparation and processing errors.

Your Schedule 1 will be available almost immediately (once your return is accepted by the IRS) through your software developer/transmitter—no more waiting for it to come in the mail!

NOTE: Taxpayers who report 25 or more vehicles for any tax period are required by statute to electronically file their Form 2290 tax return.

To file your excise tax forms electronically you will need to select an approved software provider for the tax forms you want to file. There is a minimal fee charged to file electronically that varies by provider. Find Form 2290 provider information by accessing www.irs.gov/trucker.

## OPTIONS FOR PAYING YOUR HEAVY HIGHWAY VEHICLE USE TAX

Two methods of paying your Heavy Highway Vehicle Use Tax are available when you electronically fil<u>e your Form 2290 tax return.</u>

## Arrange an Electronic Funds Withdrawal (EFW)

You can e-file your Form 2290 tax return and e-pay in a single step by authorizing an electronic funds withdrawal (EFW) through your tax preparation software provider.

Features and benefits of EFW:

It's free, There are no service charges for using this payment option. However, please check with your financial institution about any fees it may charge. You must know your financial institution's routing transit number and account number to enroll.

It's safe and secure. Payment information will be used only for the tax payment you authorize. Bank account information is safeguarded along with other tax information.

It's timely. The electronic payment will be effective (i.e., settled) on the date the return or form is e-filed.

It's convenient. You can e-file and e-pay in a single step. You will make your payment arrangements at the same time you e-file.

## Inroll in The Electronic Federal Tax Payment System (EFTPS)

EFTPS is a free service offered by the U.S. Department of the Treasury to help business and individual taxpayers conveniently pay their federal taxes electronically.

Features and benefits of EFTPS:

It's free.

It's fast. You can make a tax payment in minutes.

It's accurate. You can review your information before it is sent.

It's convenient. You can make a payment from anywhere by phone or Internet 24 hours a day, 7 days a week. You can schedule a business payment up to 120 days in advance (or an individual payment up to 365 days in advance).

It's secure. EFTPS offers the highest levels of security.

It's easy to use. A step-by-step process tells you what information you need to successfully complete your payment.
